## 6. Planning applications

Planning applications, District Council decisions, and appeals

- a) Planning applications
  - (i) DC/22/1723/FUL

Address: Foxfield House, School Road, Great Wratting CB9 7HA

Applicant: Mr Gary Fox

Proposal: One detached cart lodge

AGREED that the Parish Counci had no observations to make.

(ii) DC/22/1732/HH

Address: High Gables, The Street, Great Wratting CB7 9HQ

Applicants: Mr and Mrs Yates

Proposal: (a) single-storey infill linking existing house and annexe; (b) ground floor rear windows replaced with bi-fold doors and insertion of one window.

AGREED that while it appeared that the use of the annexe was different from that in the previous planning consent the Parish Council had no objection to the two buildings being joined together.

b) Planning decisions (made by District Council) – for information only (no details were available)

## 5. Local authority reports

b) West Suffolk District Council

Topics covered by District Cllr Peter Stevens included:

 Anaerobic digester: He had asked for details of traffic movements which the digester would be expected to generate. He emphasised that the decision on the digester would be made by the County Council, not the District Council. He will keep the Parish Council informed of developments.

- Road-sweeping: Parish Council members told him that although they were pleased that part of School Road had been cleaned it now needed doing again. Several members had reported the problem online.
- Ocost of living crisis: He said the District Council was helping some people who were struggling. It was also helping businesses. It was encouraging communities to have, for example, "welcome afternoons" in village halls, offering residents a warm place to meet. There were details on the District Council website; a link to this will be sent out via the e-mail tree.

PS DF

- Anglian Water site, Little Wratting: The District Council had taken enforcement action, requiring Anglian Water to replace trees which had died. Cllr Fisk said some new trees had already been planted.
- o <u>Karro Food Group wall</u>: He said there was little the District Council could do about the demolition of the wall.
- <u>Little Wratting</u>: The possibility of Little Wratting having a Parish Council had been discussed again.

#### 7. Highways

Cllr Holloway said little progress was being made but he was due to have a meeting with Matt Hancock MP and County Cllr Bobby Bennett in January, when there would be a meeting of representatives from seven local villages.

He said the police were using Automatic Number Plate Recognition cameras in some local villages, but not in Great Wratting. He plans to try to get the village included.

District Cllr Stevens said he had raised the issue of traffic problems with County Cllr Richard Smith (the County Council member with responsibility for transport strategy) but the County Council did not have funds for traffic-calming measures.

Cllr Judge said he had reported the problem of the low kerb in School Road, between School House and Coronation Cottages, but had been told that as no accidents had been reported on that stretch of road the County Council would not be doing anything about it.

# 8. Tree-planting

Cllr Judge reported that there had been opposition from some residents to the Parish Council's latest proposal, which was to plant trees along the top of the bank opposite Coronation Cottages. A new site for 12 trees had therefore been identified opposite the entrance to Karro Food Group's car park. Cllr Judge, who had consulted Thurlow Estate about the proposed planting, will select the species. Residents will be kept informed.

AGREED that 12 trees will be planted and that up to approx. £500 would be spent on the project. (prop THo, 2nd BJ) Residents who had previously offered to sponsor a tree are to be asked whether they are still happy to do so.

ΒJ

The trees are being planted as part of the late Queen's Green Canopy Project and to commemorate her reign.

#### 9. Flooding (BJ)

To discuss flooding issue in Moor Pasture Way / Withersfield Road area Cllr Judge said recent flooding in the gardens behind houses in Moor Pasture Way and Withersfield Road had caused concern but the Parish Council was told that Thurlow Estate, which farms the fields behind the houses, had taken action which it was hoped would solve the problem.

# 10. Litter-pick (Saturday 19<sup>th</sup> Nov 2022)

The Parish Council expressed its thanks to those residents who took part in the litter-pick. Some had stayed on afterwards to enjoy refreshments provided by the Parish Council at the Red Lion.

### 11. Barry Moore

Request for contribution to retirement gift for Barry Moore, printer of The Village Link (DF) AGREED that £25 would be donated. (prop DF, 2nd MM)

## 12. Rural Mobility Survey

<u>To consider responding to Transport East's survey on rural mobility</u> Clerk to circulate to get Councillors' views, and then respond.

#### 13. Parish Council elections 2023

The Clerk said elections for the Parish Council and District Council would be held on 4<sup>th</sup> May 2023, and the Parish Council would be asked to meet at least part of the cost. If contested (i.e. more candidates than seats) this could be as much as £3,000.

AGREED the Clerk will seek clarification from West Suffolk Council, pointing out that for Great Wratting this would be close to unaffordable.
